#### **GRANT APPLICATION GENERAL GUIDELINES:**

Westmoreland Congregational United Church of Christ charges the Board of Social Justice & Action (SJA) with managing the SJA Grant Program, which distributes funds of \$1,000-\$5,000 every December that have been raised from special congregational offerings.

Grants are awarded to non-profit organizations for targeted programs and projects that affirm and empower D.C. area individuals seeking to achieve greater opportunities and self-sufficiency.

Recipients have been awarded grants for programmatic activities that go beyond meeting basic needs, to help individuals transcend barriers to independence, including through housing; medical care; education; job training; legal assistance; and transitions after incarceration, detention, or homelessness.

#### **ELIGIBILITY CRITERIA:**

- Funds must be targeted toward a *specific* program or project consistent with Westmoreland's commitment to social justice, that increases long-term empowerment for DC metro-area individuals.
- Organizations must be of a size whereby a modest grant could have an impact;
- The Executive Director's salary should be commensurate with those at comparable DC-area nonprofits.
- Applicants must provide a final report demonstrating that funds were used in the manner intended.
- If there is an extenuating circumstance that causes a change of scope of the use of funds during the grant year, we would expect notification and documentation within 45 days of these changes.
